





# MEMORANDA.

The valuation of taxable property shall, so far as possible, be ascertained from the last assessment roll of the town after revision by the assessors.

A warrant for the collection of a tax voted by the district shall not be delivered to the collector until the thirty-first day after the tax was voted.

The collector must execute a bond to the trustee which shall be filed with the town clerk before the delivery of the warrant.

Collectors become personally liable for all taxes lost by reason of failure to have warrants renewed before their expiration.

No renewal can be for a longer time than that for which the warrant was originally issued.

All returns of unpaid taxes must be made at the time the collector is required by law to return his warrant. Such returns must be in the same form as upon the assessment roll and sworn to by the collector. Upon receiving such account the trustee shall certify to the same and immediately transmit it to the County Treasurer. This should be done before the 1st of December of each year that the delinquent tax may be assessed with the tax of the same year.

Within fifteen days after any tax list and warrant shall have been returned by a collector, the trustees shall file the same with the town clerk.
